### **EVC Training and Re-validation Courses**

Colleagues are reminded that it is a mandatory requirement for all maintained schools to have an EVC in post who has completed (or revalidated) EVC Training within the last 3 years. The Department of Education recommends this approach for all schools.

There are still places available on the last courses for this year:

EVC Training (9 am - 3.30 pm, £150.00) Wednesday 26th June EVC Re-validation (1 - 4.30 pm, £80.00) Tuesday 25th June

Course dates have now been set for the start of the new academic year: EVC Training (9 am - 3.30 pm, £160.00) Wednesday 18th September EVC Re-validation (1 - 4.30 pm, £85.00) Tuesday 17th September

All courses take place at the Lowther Adventure Centre, Glendon, Kettering, Northamptonshire, NN14 1QF.

## Visit Leader Training

Do you want to build the confidence and competence of your colleagues to lead Educational Visits?

OEAP Visit Leader Training comprises theory and practice modules that can be delivered at your school as half-day courses or together as a one-day course directed at colleagues who plan to lead visits off-site with parties of children and young people.

It is a practically based course which deals with dynamic risk-benefit assessment and allows the sharing of best practice together with opportunities to raise issues directly related to your setting. The practical module course is delivered outdoors and includes safety at water margins, safety at public access sites, safety on roads, safety in vehicles and simple way-finding.

Course costs are £700 (half-day Theory only) / £900 (full day Theory and Practice) for up to 20 people.

### **Diligence checks on Providers**

Schools are reminded of the requirement to provide evidence of diligence checks completed on third party providers. If a third party provider is providing an activity e.g. Theatre workshop / Circus Skills and they do not hold a Learning Outside the Classroom Quality Badge\*, then the school should ensure that the provider completes and returns a Provider Statement (Please download from **<u>oeapng.info</u>** 8.1q general provider or 8.1r Swimming pools). Copies of Provider risk assessments alone are not sufficient. *NB. The LOTC Quality Badge provides appropriate evidence without a provider statement but should be checked to ensure it remains in-date and covers your planned activities.*

### North Northamptonshire Council (NNC) Educational Visits Audit

#### Message from NNC:

"All maintained schools in North Northamptonshire are asked to complete our online form (link below) as part of our yearly review of Educational Visits. This form relates to the <u>North</u> <u>Northamptonshire Council policy</u> for the Management of Learning Outside the Classroom. Its completion ensures we continue to meet the highest standards and follow national guidelines.

You should complete this form as soon as possible and it must be no later than 14th June 2024. The form should be completed by the responsible person/Educational Visits co-ordinator."

### eVisit update

#### 1. Email addresses

There have been a number of recent instances of school staff missing eVisit notifications because their email addresses recorded on eVisit are not up to date. Individual account maintenance is the responsibility of the school not LOLT. All EVCs / Establishment Administrators are recommended to double check that school email addresses are up to date.

#### 2. Staff who have left your school or setting

Once staff have left your school or setting it is possible to disable their account but not to remove their eVisit profile. This is because the individual profiles are part of the audit trail for past visits.


To disable their account go to 'Manage Users' and do a user search until you locate their profile. On the security tab change the radio button adjacent to 'Active?' to NO and 'Locked Out?' to YES. This member of staff will no longer appear in the drop-down lists of available staff from your establishment.

#### 3. Adding a new user / updating an existing user

Many users seem to come unstuck on adding or updating users on eVisit. A reminder that it is a 3-stage process clearly set out in the Setting up a New User document which can be found in the Document Library, Reference Documents, User Manuals:



#### 4. Setting up an activity leader

The process is initiated by uploading a valid First Aid certificate to the individual's eVisit profile, you will then be able to select the activity you wish them to be endorsed for from the drop-down list. To complete the endorsement request you need to upload evidence of additional training and competence and then submit to the HT / OEA for approval.

### **Schools Allergy Code**

Benedict Blythe was a 5 year old who loved going to school. He had suffered multiple allergies from a young age that his parents were practised at managing. On 1 December 2021, while at school, he ate a snack and went into anaphylaxis. Rushed to hospital, he died a few hours later. One year later his parents established the Benedict Blythe Foundation (BBF) to raise allergy awareness and support educators. The BBF has put together a Schools Allergy Code which outlines best practice and can help schools to keep pupils with allergies safe. Helen Blythe from BBF states "Many schools may believe that if they don't have a child at the moment with an allergy, there's no need for them to have a policy in place. But we know that 30% of allergic reactions take place in children who have no known history of allergy" Full information and resource downloads can be found here:

### Differential course fees for pupils in receipt of Free School Meals at Longtown Outdoor Learning Centre.

Longtown Outdoor Learning Trust (LOLT) and the Wilson Foundation work in partnership to ensure that no pupil is prevented from accessing a residential outdoor education programme at Longtown Outdoor Learning due to financial hardship. Following a review of Longtown's bursary policies it has been decided to simplify the procedures for accessing bursary funding. Any pupil in receipt of Free School Meals will automatically be entitled to attend a course at Longtown at the bursary rate (broadly equivalent to a 30% reduction of course fees). This figure has been calculated to exceed the board and lodging exemption identified above. Children who are not in receipt of Free School Meals but whose parents are struggling to make ends meet can still apply for the Discretionary Bursary. The Discretionary Bursary Fund is for families that the school has identified as being in significant need of support in order for their child to attend a course. To apply for a hardship bursary the school needs to download and complete an application which must then be submitted to LOLT for consideration. The bursaries for Northamptonshire pupils are funded by the Wilson Foundation and those for pupils from other counties are funded by LOLT.
